



## KFTE, PLANET RADIO 96.5 FM OFFICIAL CONTEST RULES

- I. How to Enter a Contest
  - a. The **KFTE, Planet Radio 96.5 FM** contest will begin on the date specified in the specific rules.
  - b. Entry method is at the discretion of management and in some cases the on-air personality.
- II. Eligibility Restrictions
  - a. Contests are open to all **KFTE, Planet Radio 96.5 FM** listeners. Certain contests may require that the winner be 18 or older or 21 or older. Employees and the families of employees of Regent Broadcasting of Lafayette, its affiliates, its affiliated advertising agencies, participating sponsors/promotional partners, other radio stations in the Lafayette area and the members of their immediate households are ineligible to participate or win.
  - b. Listeners are eligible to win a contest only once per calendar month. One winner per household per contest per calendar month.
  - c. Listeners are eligible to win a prize valued at \$600.00 or more only once every six months.
- III. Claiming Prizes
  - a. All prizes or prize certificates may be picked up at the offices of **KFTE, Planet Radio 96.5 FM**, 1749 Bertrand Drive, Lafayette, LA 70506. The winner will forfeit any prize or prize certificate not claimed within ten working days of winning. In the event that a prize or prize certificate is mailed to the winner it will be with the prior written consent of the winner and therefore the winner assumes the risk of arrival. **KFTE, Planet Radio 96.5 FM** is not responsible for the safe arrival of a prize or prize certificate.
  - b. Contest prizes are non-transferable. Prizes may not be substituted or redeemed for cash.
- IV. Selection of Winners
  - a. Decisions of station management with respect to the contests are final.
- V. Conditions
  - a. Payments of all federal, state and local taxes are the winner's sole responsibility. Winners may be required to sign an IRS Form 1099 or the equivalent.
  - b. By participating in the contest the winner or winners agree to have their name, voice or likeness used in any advertising or broadcasting material related to the contest, and to sign a publicity release prior to acceptance of the prize.



- c. Contest winners will be required to sign a liability release prior to acceptance of any prize valued at \$600.00 or greater or which prize includes the provision of transportation, whether or not such transportation is provided by **KFTE, Planet Radio 96.5 FM**. Pursuant to the liability release, the winners will agree *not* to hold **KFTE, Planet Radio 96.5 FM**, its employees and agents responsible for late, lost or misdirected mail, technological errors, and/or failures of telephone systems or the internet.
- VI. **KFTE, Planet Radio 96.5 FM** reserves the right to make changes in the rules of the contest which will become effective upon announcement.
- VII. No purchase is necessary. The contest is void where prohibited.
- VIII. Failure to comply with the contest rules may result in a contestant's disqualification.
